Intern Job Positions in P. R. of China

Current students who have been approved by the university can consider applying for an internship to teach English at schools, kindergartens or language tutoring centres in Tianjin, China.

Date of Position Application

Recruitment is open throughout the year.

Starting Date of the Position

A successful applicant will be informed of the starting date of employment.

Duration of Internship

180 days (possibly offered an ongoing position for 12 months after successful fulfillment)

Location of Internship

City of Tianjin, China

Eligibility for the Position

1. The applicant is a native English speaker and Australian, New Zealand, British, American, Canadian or South African citizen.
2. The applicant must be a current university student, with a preference for reading a major of education, language or literature.
(The university must be listed online by Ministry of Education of P. R. of China – see attached list)
3. The applicant must be below the age of 45.

Benefits of the Position

1. Offered an internship for 180 days (possibly offered an ongoing position after successful fulfillment).
2. Paid a salary based on the internship contract.
3. Free accommodation, excluding utility costs.
4. Reimbursed a free return air ticket of RMB 6000 (It will be reimbursed after a full-term contract is accomplished).
5. Reimbursed travel to China insurance cover for 180 days, including medical and hospital expenses, of RMB 2000 (It will be reimbursed when the applicant arrives at the destination and fulfills the period of internship as agreed).
6. Free airport pickup.

Documents to be Submitted for Application:

1. Official Form – Overseas University Student to Apply for Internship in Tianjin (To be provided by MT Education Consultancy).
2. An original letter of internship approval issued by the applicant’s university.
3. 2-minute video of self-introduction in English.
4. A copy of the valid passport page including personal information.
5. A passport photo (e-copy or scanned).
6. An original certificate of a non-criminal record issued by the Police (to be provided after the internship offer letter issued by the employer).

Procedure of the application:

1. The applicant directly sends application documents listed above to M & T Education’s email address: mted@mail.com or mtedconsultancy@hotmail.com
2. **M & T Education** will advise the applicant in writing to conduct a Skype interview.
3. The successful applicant will be advised in writing to apply for a visa to China with the offer letter of internship in Tianjin. Fee will be paid by the applicant.
4. The applicant must purchase a return air ticket after being granted visa to China.
5. The applicant must purchase travel insurance cover after receiving the visa.
